

HOUSE STANDING COMMITTEE APPOINTMENTS

February 8, 2023

Speaker of the Ohio House, Jason Stephens (Kitts Hill), released the names of the republicans appointed to the 28 standing house committees that will be doing important legislative work during the 135th General Assembly. Minority Leader Allison Russo (Upper Arlington) announced democrat appointees last week. Standing committees are subject matter focused and an early stop in the legislative process for most bills. Committees are the site where testimony is offered, amendments considered, and votes taken that determine whether a bill will languish in committee or receive further attention from the full house and senate. The republican party appointments were delayed due to the ongoing infighting that became public in early January during the battle over who would assume the powerful Speaker of the House position. Ultimately Stephens was elected Speaker largely due to the 32 democrat votes that aligned with 22 republicans to create the unexpected result. The hard feelings generated by this vote remain an issue and may factor into how the house handles its business going forward.

The make-up and leadership of these committees can be indicative of how a particular session of the General Assembly is likely to unfold. Republicans hold 68% of the house seats and democrats 32% in the current legislature, and this year's committee appointments reflect similar percentages in the number of republicans and democrats named to each committee. That proportionality could be important in decision-making within and outside the committees.

Following are the names and brief biographies of members of the standing committees most likely to be working on bills of particular interest to nurses and the nursing profession. (Source: ohiohouse.gov as of February 8, 2023).

Health Provider Services Committee

Chair: Al Cutrona (R-Youngstown)

Rep. Cutrona is serving his 3rd term in the house. He holds a bachelor's degree in political science and history from Youngstown State University and earned a Juris Doctorate from Case Western Reserve University School of Law. Cutrona currently holds a position as the COO for a large tri-county infectious disease medical practice and is practicing at a consumer bankruptcy law firm, Amourgis & Associates. He is a lifetime member of the NRA and describes himself as a proud Hispanic Italian. His father is a leading physician in infectious diseases. His mother is a real estate agent.

Vice chair: Jennifer Gross (R-West Chester)

Rep. Gross is serving her 2nd term in the House. She is a 21-year Air Force veteran having retired from the military in 2008. She has been a family nurse practitioner for over 16 years and a registered nurse for over 30 years. Prior to becoming an NP, she managed a \$3 million territory for Eli Lilly. Most recently, she participated as a sub-investigator for Operation WARP Speed developing treatments for COVID 19. She is married with two children and believes in strong public policy that supports Ohio business success, legislation that supports and protects the unborn, and will uphold Ohioan's Constitutional freedoms.

Ranking Minority Member: Anita Somani (D-Dublin)

Rep. Somani is serving her first term in the house. She is a practicing OB/GYN at OhioHealth having earned her medical degree from the Medical College of Ohio in Toledo. In addition to her medical practice, she serves as co-chair of the Physicians' Action Network and is the State Director for South Asians for America Services Board. She is also a board member of the Columbus Medical Association and Planned Parenthood of Ohio. Her priorities include working for quality and affordable healthcare, sensible gun legislation, and fully investing in public education so every child has the tools needed to succeed. Rep. Somani is a first-generation immigrant from India. She is married with two children and has completed ten half marathons.

Members: Rachel Baker (D-Anderson Township)

Rep. Baker is serving her first term in the Ohio house. She holds a bachelor's degree in nursing from the University of Cincinnati, a masters' degree in social work from the University of Michigan, and a PhD in nursing from the University of Cincinnati. Professionally, she is a nurse researcher providing leadership and strategic planning related to a healthcare system's nursing evidence-based practice and research activities. She also is an adjunct instructor for graduate nursing students at several universities. She volunteers as a Court-Appointed Special Advocate providing support for children experiencing abuse and neglect. She is the mother of three children all of whom are volunteers and active in school orchestras, and multiple athletic teams.

Rep Tim Barhorst (R-Ft Loraime)

Rep. Barhorst is serving his 2nd term in the Ohio house. He holds a bachelor's degree from Wright State University and is a founder of financial planning group services in Ohio and the Midwest and owns and operates a local restaurant in Celina. Rep. Barhorst wants to use his small business experience to improve how government works for people and to find solutions to the challenging issues facing Ohio. He has one child.

Rep. Adam Bird (R-New Richmond)

Rep. Bird is serving his 2nd term in the Ohio house. He describes himself as an advocate for Ohio's schools and students having spent three decades as a leader in public education as a teacher, assistant principal, principal, and superintendent at Wester Brown Senior High School, Batavia Middle School, and New Richmond Exempted Village School District. He is married with four adult children and five grandchildren.

Rep. Darnell T. Brewer (D-Cleveland)

Rep. Brewer is serving his first term in the Ohio House. He was awarded a bachelor of arts degree in urban studies with a minor in communications and a certificate in nonprofit management from Cleveland State University. He also holds a master's degree in legal studies from Cleveland State University School of Law and received certification as a community health worker (CHW) and as an Ohio prevention specialist II. He has served as a social services coordinator for over 15 years and held positions as an assistant administrator, parent liaison, WAVE meditation training and providers, and truancy officer with Cleveland Public Schools.

Rep. Jamie Callender (R-Concord)

Rep. Callender is serving his 3rd term in the Ohio house. He earned his undergraduate degree from Cleveland State University and a law degree from Cleveland-Marshall College of Law. He continues to practice law at a small law office in Lake County and has taught at Kent State for over 12 years. He received the NRA's Defender of the 2nd Amendment Award for his efforts to protect Constitutional rights and is a two-time winner of the Watchdog of the Treasury Award. He and his family reside in Concord.

Rep. Beth Liston (D-Dublin)

Rep. Liston is serving her 3rd term in the Ohio house. She earned her medical degree and a PhD from The Ohio State University and subsequently trained in internal medicine and pediatrics at Yale New Haven Hospital. Upon completing her residency, she joined the faculty at OSU. Clinically, she has worked as a hospitalist at OSU Wexner Medical Center and Nationwide Children's Hospital. Liston has been a member of the House Health Committee during her previous terms in office and is a past president of the Columbus Medical Association and a member of the Dublin-Worthington Rotary. She is married with two children.

Rep. Susan Manchester (R-Waynesfield)

Rep. Manchester is serving her 3rd term in the Ohio House. She grew up on a family farm and went on to graduate from The Ohio State University with degrees in psychology and political science. Following graduation, she worked in Washington D.C. for Congressman Jim Jordan. Upon returning to Ohio, she began working with a nonprofit organization focused on mentoring children. She served on the House Health Committee during a previous term and chaired the House Families, Aging and Human Services Committee. She also co-chaired the Ohio Legislative Children's Caucus and has been honored for her work by the Public Children's Services Association and recognized as a champion of children by the Ohio Children's Alliance.

Rep. Melanie Miller (R-Ashland)

Rep. Miller is serving her 1st term in the Ohio House. She holds a bachelor of arts degree in communications and digital media and film from Cleveland State University and is a graduate of the Ashland Area Chamber of Commerce Leadership Ashland Program. Currently, she serves as Mayor of Ashland and as the executive director of the Ashland Pregnancy Care Center (APCC). Prior to joining APCC, she was the youth ministries director at the Salvation Army Kroc Community Center in Ashland. She is a former dancer for the Cleveland Cavaliers and holds several beauty pageant titles. She also worked in on-air television for WBNX, CW, and the TCT network.

Rep. Terrence Upchurch (D-Cleveland)

Rep. Upchurch is serving his first term in the Ohio house. He earned a bachelor's degree in political science from Cleveland State University and is pursuing a master's of public administration from Villanova University. He recently served as a special assistant to Cleveland City Council and worked alongside Cuyahoga County Councilman Anthony Hairston. These experiences have given him a keen understanding of the nuances of government. He wants to reverse the impact his constituents have felt by the continuous legislative cuts to community resources.

Rep. Tom Young (R-Washington Township)

Chair: Rep. Scott Lipps (R-Franklin)

Rep. Munira Yasin Abdullahi (D-Columbus)

Rep. Abdullahi is serving her first term in the Ohio house. She grew up in Columbus and graduated from the Columbus Alternative High School. She holds a bachelor's degree in political science and international relations from The Ohio State University. She began her public service working in a nonprofit advocating for and promoting youth development, leadership, and community service. As a person with type-1 diabetes, she is especially passionate about providing affordable health care for all. Rep. Steve Demetriou (R-Bainbridge Township)

Rep. Demetriou is serving his first term in the Ohio house. He studied economics at the U.S. Military Academy, West Point where he earned a bachelor's degree. After West Point, he was commissioned as an infantry officer in the U.S. Army. He completed Army ranger and airborne training and served in Afghanistan during Operation Enduring Freedom. He was awarded the Bronze Medal for Meritorious Service. Demetriou now owns an investment business with his family. He and his wife have two young children.

Rep. Michele Grim (D-Toledo)

Rep. Grim is serving her first term in the Ohio house. She earned a doctorate in law and policy from Northeastern University and a master's in public health from the University of Toledo. Prior to her election to the house, she was an at-large member of the Toledo City Council where she established the first stand-alone committee on health. She spearheaded Toledo's groundbreaking medical debt relief initiative and worked to strengthen medical care for the underserved.

Rep. Adam Holmes (R-Nashport)

Rep. Holmes was first appointed to the Ohio house during the 133rd General Assembly. This will be his 3rd term. He earned a bachelor of science degree in political science from the U.S. Naval Academy and a master's in global leadership from the University of San Diego. He spent 27 years in the U.S. Marine Corps retiring as a colonel in 2016. His military experience includes 40 combat missions supporting Operation Iraqi Freedom and he logged 3000 flight hours supporting crisis response missions in multiple locations. He is now the CEO of Frueh Enterprises, a mechanical and industrial contracting company, in Zanesville. He is married with two children.

Rep. Kris Jordan (R-Ostrander)

Rep. Jordan is serving his 4th term in the Ohio house after completing two terms in the Ohio senate. He was first elected to the house in 2008 after serving six years as a County Commissioner for Delaware County. Jordan holds a bachelor's degree in political science from The Ohio State University. He is an active member of the NRA and Delaware Right to Life and the Farm Bureau. He describes himself as a strong social conservative, having been named Watchdog of the Treasury twice and receiving a 100% conservative rating from the American Conservative Union. He notes that he has never voted for a tax increase.

Rep. Angela King (R-Celina)

Rep. King is serving her first term in the Ohio house. She holds a bachelor of science degree in organizational leadership and a master's degree in business administration both from Wright State University. She is a small business owner and grew up on a family farm, the oldest of five children. Her public service career includes serving on the Celina City Council for 11 years and as the Mercer County Recorder for 11 years. When she discovered her infant daughter was deaf she became a strong advocate for the deaf and hard of hearing. She is a licensed realtor and a former member of the Ohio Speech-Language Pathology and Audiology Board and the Ohio Housing Trust Fund Advisory Committee, and a current board member for the Western Ohio Community Action Partnership.
